Annual Learning Event

- Principled Evaluation (3 streams)
 - * 158 participants
 - * 2017: 140 / 2016: 108 / 2015: 115
 - * 75% Federal Gov't Employees
 - * 36% less than 4 years of evaluation experience
 - * 48% first time participated in ALE
 - * 83% agree that the event was useful and valuable
 - * 84% agree that satisfactory networking opportunities
 - * Keynote address was relevant (91%) and interesting (97%)
 - * Reduced the registration fees (\$400 \rightarrow \$250)
 - Increase in sponsors
